

**VOLUNTEERS NEEDED TO PROVIDE
TRANSPORTATION OPTIONS FOR NON-DRIVING SENIORS
OR VISUALLY IMPAIRED ADULTS**

	INDEPENDENT TRANSPORTATION NETWORK OKC (ITN)	RSVP PROVIDE-A-RIDE
ELIGIBILITY	Valid driver's licence and 3 years driving experience. Clean driving record and background check. Proof of liability insurance, current vehicle registration.	Aged 50+ and have own vehicle in good repair. Pass background check and have clean motor vehicle record.
OTHER REQUIREMENTS	Personal references from 3 non-relatives. Participate in ITNCO interview and training.	Meet and Interview with program coordinator prior to first ride. Procedural training provided.
SERVICE AREA	Oklahoma County/metro service area by arrangement. Driver may select which rides to accept.	Oklahoma County. Driver may choose which geographic area to serve.
TRIP PARAMETERS	Destination may be shopping, hair or medical appointment, friend's home, or other business. Driver may arrange drop off/pick up for flexibility.	Riders go to medical appointments only (may add pharmacy if related to appointment). Driver remains with client throughout and insures s/he is safely back inside home.
RIDERS	Riders will have clear background check to be eligible for service and are interviewed before acceptance. Walkers, canes, portable oxygen okay; no wheelchairs.	Riders will have clear background check to be eligible for service and are interviewed before acceptance. Walkers, canes, portable oxygen okay; no wheelchairs.
SCHEDULING	Dispatcher sends out ride request; volunteer driver responds to confirm if desired. May select preferred window of time. (Rides offered 24/7)	Volunteer preselects a block of time preferred for being assigned trips (e.g. Tues. a.m. or Wed. p.m.). Ride hours are 8:30 a.m. to 3:00 p.m.
WEATHER	Not expected to drive in unsafe conditions.	Not expected to drive in unsafe conditions.
INSURANCE	ITN provides supplemental accident and liability insurance.	RSVP provides supplemental accident and liability insurance.
COMPENSATION	May receive mileage reimbursement. May opt to donate miles and take income tax deduction. May "bank" mileage for future use as a passenger or to gift to a loved one.	May receive mileage reimbursement round trip from driver's home. May opt to donate miles and take income tax deduction.
